Dear St. Peter's Family,

If the world did not know the Episcopal Church two months ago, it does now. In April, many of us were quite proud to see Barbara Bush's funeral held at St. Martin's Episcopal Church in Houston. In May, our church was in front of billions across the world when the Most Rev. Michael Curry, the Presiding Bishop of the Episcopal Church, delivered the sermon at the royal wedding of Prince Harry and Meghan Markle. Bishop Curry represented the Episcopal Church to the world, and he did so with the most simple and profound message; there is power in love.

Yes, the elite congregation at Windsor Palace gathered together in the presence of God to witness and bless the joining together of Prince Harry and Meghan Markle, but apparently there was a larger gathering to take place on this occasion. The VIPs gathered at St. George's chapel; Episcopalians across the country gathered for watch parties; the worldwide audience gathered for this celebratory occasion; and our Presiding Bishop, Michael Curry, brought the love of Christ to all those gathered across the world.

Yes, some would say that this couple is special because they are "royal" and it's not every day that a wedding is televised across the world. Yet, Bishop Curry preached a message of love that can be the same love to which every marriage can witness. Two billion people across the world either showed up or tuned in to see two special individuals marry one another, but God chose to do more with that holy moment. Bishop Curry said, "Two young people fell in love, and we all showed up. But it's not just for and about a young couple, who we rejoice with. It's more than that." And, we pray this much every time a couple is married in the Episcopal church; we pray for the couple, that God would make their life together a sign of Christ's love to this sinful and broken world. In the only way Bishop Curry can, he preached about true love.

Yes, the Episcopal Church has had its differences, but on this occasion, at a royal wedding, Bishop Curry was able to bring our church together to hear the message on which our church is founded; there is power in the love of Jesus Christ. Since the day he was elected Presiding Bishop (by an overwhelming majority), Bishop Curry has inspired our church with his passion and focus; he remains true to the Good News of Jesus Christ. At the royal wedding, the Episcopal Church came together to hear once again the truth that unites us to God and one another; there is power in love.

Yes, it is unusual for clergy outside the Church of England to deliver the sermon at a royal wedding, and Bishop Curry seemed to be the right choice for this unique occasion. While he made a few in the chapel congregation uncomfortable (some have thought this was a good thing), Bishop Curry preached a message that resonated across the world and represented the ministry we share in the larger Anglican Communion. The larger Anglican Communion was gathered in that moment, and our primate preached the timeless truth with his fresh voice that many of us have come to adore. Yes, it was a "lively" sermon; there is power in love.

Two billion people heard Bishop Curry preach, and he was able to evoke a response from royalty, rugby players, and real people across the world. Yes, he inspired many of us, and it reminds me that many of us can do the same in our everyday lives. We too are called to proclaim by word and example the Good News of God in Christ. There is power in love.

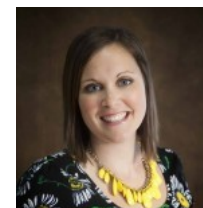

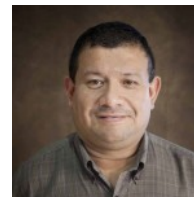

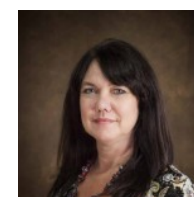

### A Message from Fr Mike

"Why We Worship As We Do"

Have you ever wondered why we worship as we do, i.e., using a Book of Common Prayer, rubrical norms, seasonal changes; observing feasts, fasts, saints' days; standing for some things and kneeling for others; praying formally, communally; making the Sign of the Cross over ourselves as well as over things: bread, wine, water, linens, icons, incense, candles, etc.; bless with manual acts; recite creeds; process in and out and around; proclaim the Holy Gospel from the center of the Nave; celebrate the Holy Eucharist within the Sanctuary; consecrate Bishops and ordain Priests and Deacons; maintain seven Sacraments; corporately confess our sins and receive absolution and remission of them; chant and sing responsively; pray for the Departed and baptize infants...?

Must we do any of this when most other believers we may know do not? Are we guilty of obscuring the simple message of Jesus? Does God need (desire) all this fuss

and formalism? Has someone convinced you that the blazingly awe-full I AM WHO I AM is, perhaps, Informal...? Would YOU leave your shoes on before this God?

I ask myself these questions all the time and revel in these outward manifestations of the inward reality of our great and glorious God and Savior. Embodied worship is clearly different from mere cerebral processing. The word 'worship' comes to us from the Old English 'woerthscipe', meaning to ascribe worth(iness), respect, reverence and love towards God. Worship is The One Thing we must do together, frequently, with solemn dignity and respectful decorum. Exhibiting worshipful propriety and good taste glorifies our beautiful, generous Lord. It is, as the liturgy says so succinctly, "our sacrifice of praise and thanksgiving", "which we offer unto thy divine Majesty", "our bounden duty and service."

And, yes, it makes us Catholic Christians. And One. And Holy. And Apostolic. We come by this via Holy Tradition, the witness of the Apostles and their successors, and Holy Scripture rightly interpreted. It makes Reason-able sense.

When we gather for the Divine Office, the Opus Dei (Work of God), the Celestial Liturgy, nothing too small, too plain, too mundane or too pedestrian will do. Indeed, "our selves, our souls and bodies" must pulse with all the life of the One Who Is Life. Do not think that God gives Episcopalians the summer off! ☺

"For thou only art holy;  
thou only art the Lord;  
thou only, O Christ,

## May Vestry Highlights

The Vestry met on Monday, May 21, 2018 at 5:30pm. Fr. Bert opened the meeting in prayer, and then introduced Ginny Stehling, the new Parish Administrator, to the vestry.

The Vestry approved the minutes from the April 16 meeting. Due to an injury, Lou Ann Maxwell resigned from her office as Secretary to the Vestry. The Vestry elected Catherine Kern to fill the position and serve as Secretary to the Vestry.

Chrisie Jennings had sent out a financial report prior to the meeting showing that our overall income is 38% and our overall expenses are 32%. Catherine Schulte was present to add detail to the report. The Vestry approved the Financial Report as presented.

Richard Mosty, Chancellor of the Parish and member of the Episcopal Church Foundation (DWTX) Board of Directors, reported on funds the parish has with the Foundation. He also distributed a packet with information on the performance of the funds and the legalities of each fund.

Dee Elliott, the School Board/Vestry liaison, reported on the ministry of the school. Dee had previously emailed her report to the Vestry. She highlighted that enrollment remains full and enrollment for the upcoming school year is filling up quickly. Also, it was reported that the school busses are in need of repair and that Ms. Boutin is working to determine the current value of the busses and inquire about purchase of a replacement bus for the ministry of the school.

Brooksie Bledsoe reported on behalf of the ECW. The Cottage Shop is in great need of volunteers during the day. She also reported that the Lenten Soup Suppers were a success and that Fr. Mike was the recent speaker at the ECW General Meeting. It was also discussed that Lou Ann Maxwell will work with Fr. Bert and church staff on how to communicate the opportunity to serve at the Cottage Shop.

Brooksie Bledsoe reported on behalf of the Newcomers Ministry. She reported that nine newcomers attended the recent Newcomers gathering and that a number have expressed interest in attending the fall gathering.

Lee Underwood, Junior Warden, reported to the Vestry. Lee reported that the west wall of the school building is leaking and needs to be sealed again. The vestry approved the cost of the sealant to resolve the issue. Lee shared that the church is still waiting on a bid from Starkey Pest Control for termite care before making a decision on the path to take with termite inspection. Stephen Drane mentioned in the property report that he is looking into the purchase of a new cloth over the columbarium. Progress on the replacement fountain was shared earlier in the meeting, and the fountain is expected to arrive by the end of the month.

Rich Schneider, Senior Warden, reported to the vestry. Rich shared that he is working with Fr. Bert on how to make the vestry meetings efficient and organized for the best use of the vestry's time.

Fr. Bert Baetz reported to the vestry. Fr. Bert spoke briefly to his first day working with our new parish administrator, Ginny Stehling. He also mentioned that he continues to work with Catherine Schulte about the development of a controller position that would assume some of the treasurer's duties while Catherine is willing to continue to serve in an advisory position in regards to the finances of the church. Fr. Bert reported on the progress made with the Christian Formation Commission. The Commission has met three times since the coaches visited in early April. The Commission has expanded to fifteen members, with David Martin chairing the Commission. The Christian Formation Commission has divided into four subgroups (Leadership, Education, Outreach, and Fellowship) with a point person for each subgroup. The vision is that the commission will interface with church staff, especially Linda Jordan, on the planning, communications, and logistics of the programs and activities in and through the parish. The entire Commission will meet again on July 31 to form a comprehensive calendar for the next program year that begins in the fall. Finally, Fr. Bert shared a letter from Bishop Reed that was addressed to the leadership of all the parishes in the Diocese. In his letter, Bishop Reed invites and encourages the people of our Diocese to participate in the 10<sup>th</sup> Abide in Me Conference on Saturday, June 9, at TMI Episcopal in San Antonio; the conference is source of renewal and learning. This year's conference is Living Stewardship, and in his letter, Bishop Reed emphasizes the importance of faithful stewardship of resources.

Under New Business, Rich Schneider reported on behalf of the Finance Commission to recommend the formation of an Endowment Board that would be tasked with reviewing current funds, making recommendations to the vestry, and developing a resolution for a new endowment that could benefit the long-term sustainability of the parish. The following parishioner were nominated and subsequently elected by the vestry to serve on the Endowment Board: Ross Rommel (Chair), Jim Hayes, Bill Crumrine, Granger MacDonald, Carter Crain, and Karen Kilgore.

Also, under New Business, Mickey Horany initiated a conversation about the use of the parish's golf carts and there will be follow up to this discussion in the future.

There was no Old Business.

### RELEASE AND WAIVER OF LIABILITY FOR A MINOR CHILD

This Release and Waiver of Liability (the "Release"), is executed \_\_\_\_\_ (date, year), by \_\_\_\_\_, a minor child (the "Participant"), and \_\_\_\_\_, the parent having legal custody and/or the legal guardian of the Participant (the "Guardian"), in favor of St. Peter's Episcopal Church (" St. Peter's" ), its Vestry, Diocese, employees, and agents. The Participant and Guardian desire that the Participant participate in St. Peter's Church activities. Participant and Guardian freely, voluntarily, and without duress execute this Release under the following terms:

1. **Waiver and Release.** Participant and Guardian release and hold harmless St. Peter's, its Vestry, Diocese, employees, and agents, from liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise from Participant's participation in the Participant Program. By signing this, Participant and Guardian discharge St. Peter's from any liability or claim that Participant or Guardian may have with respect to any bodily injury, personal injury, illness, death, or property damage that may result from Participant's participation in the Participant Program. Participant and Guardian also understand that St. Peter's does not assume any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to medical, health, or disability insurance.
2. **Medical Treatment and Insurance.** Participant and Guardian release and forever discharge St. Peter's from any claim whatsoever which arises now or later on account of any first aid, treatment, or service rendered in connection with the Participant's participation in the Participant Program or with any decision by any representative or agent of St. Peter's to exercise the power to consent to medical or dental treatment as such power may be granted and authorized in the Parental Authorization for Treatment of a Minor Child. Participant and Guardian understand that St. Peter's does not carry or maintain health, medical, or disability insurance coverage for any Participant. **Each Participant** is expected and encouraged to have medical or health insurance coverage in effect while participating in the Participant Program.

Assumption of the **Risk.** The Participant and Guardian understand that the Participant Program may include activities that may be hazardous to the Participant. Participant and Guardian assume the risk of injury or harm in these activities and release St. Peter's from all liability for injury, illness, death, or property damage resulting from the activities of the Participant's participation in the Participant Program.

4. **Indemnity Agreement.** (A) The Participant and Guardian hereby further agree to hold St. Peter's harmless from, defend and to fully indemnify it for any and all amounts, of whatever kind or nature, that may be recovered against the said St. Peter's as a result of any and all claims, or that may be asserted in the future by, through, or as a result of Participant and Guardian and/or by any other Third-Party. (B) THE INDEMNITY DESCRIBED HEREIN SHALL SPECIFICALLY INCLUDE INDEMNITY TO ST. PETER'S FOR ST. PETER'S OWN, SOLE, OR CONCURRENT NEGLIGENCE, GROSS NEGLIGENCE, AND/OR INTENTIONAL CONDUCT, IF ANY.
